Prospective bidders must have an experience of having completed at least one (1) contract that is similar to the contract to be bid, and whose value, adjusted to current prices using the NSO consumer price indices, must be at least fifty percent (50%) of the Approved Budget for the Contract (ABC) and have key personnel and equipment available for the prosecution of the contract.

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from the BAC Secretariat and inspect the Bidding Documents at the address given below from 8:00 AM to 5:00 PM.


The Bid Documents/Forms will be made available at BAC Secretariat, Mun. of Lubao upon payment of a non-refundable amount of P1,000.00 to the Treasurer's Cashier. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and at Lubao.gov.ph provided that the bidders shall pay the fee for the Bidding Documents not later than the submission of bids.

All bids must be accompanied by the bid security in any of the acceptable forms and in the amount stated in ITB Clause 1B.

Bids will be opened in the presence of the bidders' representatives who choose to attend at the address as stated above. Late bids shall not be accepted.

The Municipality of Lubao reserves the right to reject any or all bids, and accept the offer most advantageous to the Government. The MOL assumes no responsibility whatsoever to compensate or indemnify bidders for any expenses incurred in the preparation of the bid.
