**REORGANIZING THE LOCAL DISASTER RISK REDUCTION AND  
MANAGEMENT COUNCIL (LDRRMC) OF LUBAO, PAMPANGA,  
AMENDING EXECUTIVE ORDER No. 04, SERIES OF 2010**

WHEREAS, pursuant to Section 11 of R.A. 10121, known as Philippine Disaster Risk Reduction and Management Act of 2010, the Municipality of Lubao passed Executive Order No. 04 Series of 2010, Creating the LDRRMC of Lubao, Pampanga;

WHEREAS, in order for the said Executive Order to be in accord with R.A. 10121, there is a need to reorganize the composition of the Council and designate the names of each and every member thereof;

NOW, THEREFORE, I, MYLYN PINEDA-CAYABYAB, Municipal Mayor of Lubao, Pampanga, by virtue of the powers vested in me by law, do hereby create the Local Disaster Risk Reduction and Management Council of Lubao, Pampanga as follows:

**SECTION I. Creation and Composition of the Council.**

There is hereby created a Local Disaster and Risk Reduction and Management Council to be headed by the Local Chief Executive (**Mylyn P. Cayabyab**) as Chairperson, and the following Heads, CSO's and private sector representative as members.

**SECTION 2. Powers and Functions of the Council.** The Council shall have the following powers and functions:

1. Approve, monitor and evaluate the implementation of the LDRRMPs and regularly review and test the plan consistent with other national and local planning programs;


2. Ensure the integration of disaster risk reduction and climate change adaptation into local development plans, programs and budgets as a strategy in sustainable development and poverty reduction;

3. Recommend the implementation of forced or preemptive evacuation of local residents, if necessary; and

4. Convene the local council once every three (3) months or as necessary.

**SECTION 3. Effectivity.** This Executive Order shall take effect immediately.
