EXECUTIVE ORDER ORGANIZING THE MUNICIPAL ANTI-DRUG ABUSE COUNCIL

WHEREAS, DILG Memorandum Circular No. 98-227 dated December 2, 1998, Memorandum Circular No. 99-236 dated December 21, 1999, Memorandum Circular No. 2000-127 dated September 8, 2000, Memorandum Circular No. 2001-90 dated July 26, 2001, Memorandum Circular No. 2009-09 were issued to reiterate the creation/reorganization and strengthening/revitalizing of Anti-Drug Abuse Councils in all levels of local governments.

WHEREAS, creation of such is in support to the continuing campaign of the government in the fight against illegal drugs.

WHEREAS, the surge of drugs has assumed alarming proportions in the country, threat to health and a serious threat to the well-being and security of the residents due to drug

WHEREAS, the proliferation and use of illegal drugs hamper efforts aimed at promoting related crimes. peace and harmony as well as meaningful social and economic development in the country.

NOW, THEREFORE, I MYLYN P. CAYABYAB, Municipal Mayor of Lubao, Pampanga, by virtue of the powers vested in me by law, do hereby order:

Functions: Section 2.

The Municipal Anti-Drug Abuse Council shall perform the following functions:

- 1. Serve as a focal point through which various organizations and individuals work together cooperatively on planning, implementation and evaluation of programs on drug abuse prevention.
- 2. Provide for an effective mechanism for coordination of existing services and programs and those which might be developed in the immediate future;
- 3. Provide a mechanism to obtain funds, volunteer facilities and technical expertise;
- 4. Conduct information and education campaign in the ill-effect of illegal drugs, monitor and report to proper authorities drug pushers and drug users in the locality; 5. Prepare a confidential watch list of drug users and pushers found in the LGU's
- area of verification leading to the arrest and filing of appropriate charges; and 6. Perform other related responsibilities as may be assigned by competent

authorities.
