

The *Municipality of Lubao (MOL)*, through the *LGSF* intends to apply the sum of **P 490,000.00** being the Approved Budget for the Contract (ABC) to payments under the contract for *Construction of Solar Dryer At San Pedro Saug, Lubao, Pampanga PBD INFRA 2022-114*. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The *Municipality of Lubao* now invites bids for the above Procurement Project. Completion of the Works is required **Thirty (30) Calendar Days**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184. Otherwise known as the "Government Procurement Reform Act". The contract shall be awarded to the Lowest Calculated Responsive Bidder (LCRB) who was determined as such during post-qualification.
4. Interested bidders may obtain further information from BAC Secretariat and inspect the Bidding Documents at address given below from 8:00Am to 5:00Pm.
5. A complete set of Bidding Documents may be acquired by interested bidders on **June 09, 2022 – June 28, 2022** from address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Hundred Pesos (P500.00)**.
6. The Procuring Entity shall allow the bidder to present its proof of payment for the fees. The Bid Documents/Form will be made available at BAC Secretariat, Municipality of Lubao or it may also be downloaded free of charge from the website

of the Philippine Government Electronic Procurement System (PHILGEPS) provided the bidders shall pay the applicable fee for the Bidding documents not later than the submission of their bids.

7. The *Municipality of Lubao* will hold a Pre-Bid Conference¹ on _____ which shall be open to prospective bidders.
8. Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address as indicated below, (ii) online or electronic submission shall contact the given information as indicated below, or (iii) both} on or before **June 09, 2022 – June 28, 2022 until 9:00 AM**. Late bids shall not be accepted.
9. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 16.
10. Manual Bid opening shall be on **June 28, 2022 10:00 AM** at the MPDC office and/or through protected email by video conferencing or webcasting. Manual Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
11. The *Municipality of Lubao* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.


