Fund) *Environment Bamboo Hub* intends to apply the sum of **P 535,393.95** being the Approved Budget for the Contract (ABC) to payments under the contract for *Construction of Billboard at Remedios, Lubao, Pampanga, PBD INFRA 2021-085*. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The *Municipality of Lubao* now invites bids for the above Procurement Project. Completion of the Works is required **Thirty (30) Calendar Days**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from BAC Secretariat and inspect the Bidding Documents at the address given below from **8:00Am to 5:00Pm**.
5. A complete set of Bidding Documents may be acquired by interested bidders on **June 11, 2021 – June 30, 2021** from given address and website/s below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of P1,000.00*
6. The Procuring Entity shall allow the bidder to present its proof of payment for the fees *The Bid Documents/Form will be made available at BAC Secretariat, Municipality of Lubao or it may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PHILGEPS).*

7. The *Municipality of Lubao* will hold a Pre-Bid Conference<sup>1</sup> on \_\_\_\_\_ which shall be open to prospective bidders.
8. Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address as indicated below, (ii) online or electronic submission shall contact the given information as indicated below, or (iii) both} on or before **June 11, 2021- June 30, 2021 until 9:00 AM**. Late bids shall not be accepted.
9. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
10. Manual Bid opening shall be on **June 30, 2021 10:00 AM at the MPDC office** and/or through protected email by video conferencing or webcasting. Manual Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The *Municipality of Lubao* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
