

A complete set of Bidding Documents may be acquired by interested bidders on **November 12, 2021 – December 01, 2021** from given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **500.00**
6. The Procuring Entity shall allow the bidder to present its proof of payment for the fees *The Bid Documents/Form will be made available at BAC Secretariat, Municipality of Lubao or it may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PHILGEPS).*



Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address as indicated below, (ii) online or electronic submission shall contact the given information as indicated below, or (iii) both} on or before November 12, 2021- December 01, 2021 until 9:00 AM. Late bids shall not be accepted.


9. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 16.
