The Municipality of Lubao now invites bids for the SUPPLY AND DELIVERY OF GOODS FOR PAMASKONG HANDOG NI MAYORA PARA SA MGA BATA Delivery of the goods shall start Thirty (30) days from receipt of the Notice to Proceed. Bidders should completed, within Two (2) years from the date of bid conference, a contract similar to the Project. The description of an Eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to bidders
2. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (R.A.) No. 9184, otherwise known as the "Government Procurement Reform Act."
Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the

Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

3. Interested bidders may obtain further information from the Municipality of Lubao Bids and Awards Committee (BAC) Secretariat and inspect the Bidding Documents at the address given below during office hours from 9:00 a.m. to 4:00 p.m.
